Chattahoochee Valley Community College (CVCC) abides by the policies of the Alabama State Board of Education and operates on a semester system. As established by State Board Policy 705.01, a semester hour of credit (or credit hour) is then based upon the average number of hours of instruction weekly during a 15-week period with an hour of instruction defined as not less than 50 minutes of instructor/student contact. A semester system is defined as a fall semester, spring semester, and a summer term. The ratio of weekly contact hours to credit hours varies with the type of instruction being used.

Chattahoochee Valley Community College <u>associate degree programs</u> include a substantial component of college-level general education courses (core courses). The Associate of Arts and the Associate of Science degrees require 41 semester credit hours of core curriculum course work distributed among four core discipline areas: written composition (6 hours); humanities/fine arts (12 hours); natural science/mathematics (11 hours); and history, social and behavioral sciences (12 hours). The Associate in Applied Science degree requires 18 – 29 semester credit hours of core curriculum course work. The Associate in Applied Science degree program in Fire Science and Homeland Security require 28 semester credit hours of core curriculum course work. The Associate in Applied Science degree program in Medical Assisting requires 22 - 23 semester credit hours of core curriculum course work, Applied Technology requires 22 credit hours of core courses, and Nursing (ADN) requires 27 semester credit hours of education coursework.

Transfer Credit: The College's policy on granting transfer students course credit include conditions governing admission status, as noted in the <u>College Catalog and Student Handbook</u> and the College <u>Policy and Procedures Manual</u>.

- If a student has a 2.0 GPA in all previous college work attempted, all passing grades will be accepted if they are comparable to CVCC courses.
- If the student's GPA is below 2.0, only credits in which a grade of "C" or better is earned will be accepted.
- Of those accepted, only those that are applicable to the student's chosen curriculum may be used for purposes of meeting program and graduation requirements.
- Students who have satisfactorily completed required English and mathematics courses will not be required to take the COMPASS Placement Test at CVCC.

Nontraditional Credit

Chattahoochee Valley Community College awards credit based on Advanced Placement Examination Program (AP), College Level Examination Program (CLEP), Defense Activity for Non-Traditional Educational Services Support (DANTES), Service member Opportunity College (SOC), military training and educational experiences (Note: - The student is responsible for requesting- AARTS transcript by contacting the AARTS Operation Center), and a maximum of 15 hours of credit may be earned through Credit by Examination.
