Withdrawals and Refunds

Partial Withdrawal: Students who do not withdraw completely from the College but drop a class before or during the official drop/add period (August 20-22) will be refunded 100% of the tuition and other refundable fees applicable to the reduced number of credit hours. **There is no refund for partial withdrawals completed after August 22, 2012.**

Complete Withdrawal: Students who withdraw from all classes in which they are registered are due a refund according to the following criteria:

Federal Title IV
Refund/Repayment Policy
2012-2013**

Title IV regulations specify that funds are awarded to a student under the assumption that the student will attend College for the entire period for which the assistance is awarded. Title IV regulations state a student and CVCC are eligible to keep only the amount of Title IV funds earned. *All unearned Title IV funds must be refunded to the federal government or to the lending bank granting the student loans.* Therefore, when a student receives Title IV funds (Loan, Pell or SEOG) within a semester and then drops, withdraws or stops going to class before completing the 60 percent enrollment period of the term, the student becomes personally responsible for the unpaid tuition and fees. The student will owe CVCC for unpaid tuition and fees.

A Title IV student will owe CVCC

withdraws, drops or stops
going to class prior to:**

Term I Classes – September 22, 2012

Regular Term Classes – October 27, 2012

Term II Classes – November 24, 2012

If a student owes CVCC for tuition and fees due to refunded Title IV funds, a hold is placed on his/her account. When an account is on hold, the student will not be able to receive grades or register for future semesters until the amount is paid in full. Also, if student accounts are not paid timely to CVCC, the accounts will be turned over to a collection agency and will be reported to the Credit Bureau. **All students with accounts turned over to collections will be responsible for paying any collection costs.**

Financial Aid Information

How do I apply?

Complete the Free Application for Federal Student Aid (FAFSA). If applying online at www.fafsa.ed.gov allow 2-3 weeks for processing. Mailed applications will take at least 4 weeks.

Complete an application for admission to CVCC.

Provide your official transcript or GED certificate to the Admissions Office. If you are a transfer student, provide official transcripts from the college(s) you attended.

When should I apply?

For the next academic year, apply any time after January, but before the start of fall semester. Many programs have limited funding, so it is best to apply early.

How many semesters are covered?

If approved, financial aid will cover two semesters within an academic year.

What if I miss a deadline?

Initially, you will have to pay for tuition and books. However, if you qualify for financial aid, a reimbursement check will be sent to you later in the semester.

What types of financial aid are available?

Pell Grant - an award you are not required to pay back. Pell Grant amounts are based on individual or family financial circumstances.

SEOG - Supplemental Education Opportunity Grants are awarded to students who demonstrate an exceptional financial need.

College Work-Study Program - provides part-time employment opportunities for eligible students.

Federal Direct Loans - student loans - amounts are based on individual or family circumstances.

Alabama Grant Program - awarded to students who are residents of Alabama and who demonstrate exceptional need.

Other Types of Financial Aid Available•**Lifetime Learning Credit** - for college juniors, seniors, graduate students and working Americans pursuing lifelong learning to upgrade their skills.

Hope Scholarship Tax Credit - a tax credit available to eligible students during their first two years of post-secondary education.
